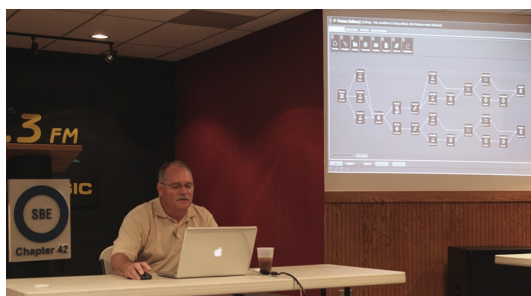
Old Business - none
